Definition of the crime

Domestic burglary & shoplifting

Assessment of trends and developments

Domestic burglary:

A steady decline in the number of burglaries since 2015. But it remains one of the most acute phenomena in property crime. The total material and financial damage is estimated at 170 million euros per year.

There is also the psychic damage and trauma victims who express themselves with difficulty through numbers.

<u>Shoplifting & theft in companies:</u>
The number of shoplifting has oscillated over the last few years between 21,000 and 25,000 incidents. The "dark number" in this phenomenon is high. The actual number of shoplifting is estimated at around 150,000 and the resulting financial loss around 24 million euros.

2. Crime strategy and coordination

Objectives of the crime strategy

Limit the individual and social impact of burglaries in buildings:

- through an effective approach at the local, national and international levels, by doing deterrence, by reducing the attractiveness of our country to burglary groups;
- 2) developing a preventive approach in which citizens and the private sector also play an active role;
- 3) starting from a targeted approach of authors, by investing in measures that disrupt the criminal process (group structure, mobility, handling, logistics, residences, etc.)
- 4) by continuing to invest in an integrated and integrated approach via a national platform where the various actors involved in the security chain can consult each other;
- 5) by providing for the follow-up of victims and appropriate measures for perpetrators;



Role of prevention in the crime strategy on state/regional/local level

- Increase and better prevention of burglaries by knowledge management and stimulating new concepts and techniques to reduce the risk of victimization
- Financial support for burglary prevention facilities by federal of local authorities
- encourage citizen participation and collaboration with professional associations
- expansion of cooperation between police and private security companies
- an integrated approach to handling
- dissuasive work on risky places through information-driven actions

Implementation of the policy (which level is responsible for the implementation and how is the implementation coordinated?)

For the field of prevention, Ministry of Home Affairs is in charge with the implementation of the policy with the support of local police forces and local authorities.
