## Doing what works: from evidence to action

### - Thematic session -

Policies should be grounded in the best available evidence. This evidence informs us about what works in public policy, its costs and benefits, both in the short and the long term. To effectively promote evidence-based policies, the EUCPN has devised a comprehensive strategy, which will be presented during this session. The EUCPN employs four criteria to assess and disseminate good practices. An assessment tool named QUALIPREV is utilised to objectively evaluate the extent to which these criteria are met. Furthermore, the EUCPN has developed two trainings for practitioners and policymakers, focusing on the fundamentals of crime prevention as well as the evaluation of crime prevention initiatives.

## Youth recruitment prevention: challenges and solutions in practice

### - Thematic session -

This session explores practical challenges and solutions related to the prevention of young people into organised crime through the experience of three successful prevention programmes, each with a different frame of reference. The Greentown Project focuses on community interventions to reduce the influence of criminal networks on children. Practitioners will share success stories, challenges and lessons learned from two cases. In the Dutch City of Tilburg, the coaching programme offers families in organised crime an exit strategy, aiming to break the vicious cycle of growing up in criminal families. The presentation outlines the project's evolution, stakeholder engagement and challenges in measuring individual interventions and overall impact. The Swedish National Council for Crime Prevention and local authorities implemented Group Violence Intervention in six locations. The example of Örebro provides insights into the effectiveness of a US preventive policing strategy in a typical Swedish city, showcasing integration into existing structures and commitment from stakeholders when applied to a different local context.



## Starting with crime prevention: training insights from the EUCPN

### - Interactive session -

This session will cover two trainings developed by the EUCPN: “Crime Prevention Fundamentals” and the “Evaluation of Crime Prevention Interventions—a practical guide for trainers and practitioners”. By delving into the basic aspects of crime prevention, the session will explore its definition and various prevention types; emphasising that it extends beyond mere awareness-raising. Additionally, participants will be introduced to the knowledge and skills necessary to comprehend and conduct evaluations of crime prevention initiatives. The session is centred around a group discussion on key steps to take in setting up evidence-based crime prevention.

### - Thematic session -

This session highlights the contribution of EU agencies, organisations and platforms in the fight against organised crime, with a specific emphasis on the recruitment of young people, individually as well as within the European Multidisciplinary Platform against Criminal Threats (EMPACT). Europol and @on will provide insights from criminal investigations improving our understanding of the modus operandi of organised crime groups when it comes to recruitment. CEPOL will illustrate how it can support Member States through specialised law enforcement training addressing the challenges of crime prevention. Efus will showcase the challenges but also potential of local authorities in countering and preventing organised crime.

### - Thematic session -

The complexity of cross-border information exchange between law enforcement, the public prosecutor and all relevant administrative bodies often hinders practitioners to implement the administrative approach in practice. By means of case studies, this session will showcase solutions for achieving cross-border information exchange for administrative purposes within the EU by presenting existing frameworks and their practical implementation. After an introduction by the ENAA, the EU Regional Information and Exchange Centre (EURIEC) will illustrate the possibilities and limitations

for the exchange of different types of information at local and national level. Italy will present their initiative to make use of SIENA for cross-border information sharing, and the Benelux Secretariat will present the unique Benelux-Police Treaty which allows cross-border information sharing for administrative purposes. Belgium will present its new 'Directorate Integrity Assessments for Public Administrations' legislation which has a provision on international cooperation.

### - Thematic session -

During this session, we will delve into the outcomes of an expert meeting aimed at analysing the complexities surrounding the involvement of youngsters into organised crime. The first presentation will unveil the results of the expert meeting, shedding light on the crime-related problem, its nature and causes, its potential consequences, modus operandi, risk and protective factors,... These insight are essential for designing targeted and effective preventive measures. Following this, the second presentation will provide valuable insights into the risk and protective factors influencing young people's involvement in organised crime groups. Delving deep into the mechanisms that drive this involvement, participants will gain a comprehensive understanding of the multifaceted nature of the issue. Lastly, in the third presentation, the OSCE will turn the spotlight on the recruitment of women and their roles within organized crime groups.

### - Thematic session -

This session provides insights into a variety of risk-based prevention programmes highlighting the benefits of multi stakeholder partnerships. The initiatives address different forms and aspects of crime prevention while showcasing how cooperation between and support to different stakeholders can be put in place. “Functional Family Therapy-Gangs” focuses on vulnerable youth coerced into criminal activities, addressing risks beyond the family context. The UNODC’s “Preventing Violence and Crime through Sport” policy guide underscores evidence-based sports interventions to prevent youth crime and recruitment by organised crime groups. The French MILDECA project (LIMIT’s) aims to prevent the involvement of young people in drug trafficking by involving all relevant actors. Finally, the Dutch “Prevention with Authority” programme tackles youth recruitment by organised crime groups through financial support to local prevention initiatives tailored to the local context and risk factors.

## Applying barrier models to tackle organised crime

A relevant tool within the administrative approach is the use of barrier models. The barrier model identifies the steps criminals must take to commit a crime, highlights which parties and opportunities make the crime possible to then determine which barriers can be implemented, by public and private partners, to effectively disrupt the work of the criminals. Participants will get the opportunity to actively explore and implement the methodology during the session.

### - Thematic session -

This session will provide the opportunity to discuss concrete actions to effectively prevent human trafficking for labour and criminal exploitation. Three presentations will set the scene with the presentation of the EUCPN Toolbox on the prevention of THB for labour exploitation, applying situational prevention theory to this phenomenon; followed by a presentation of the Council of Europe's efforts to tackle criminal exploitation outside the EU, by using the innovative method of simulation-based exercises and a final contribution by. Finally, the Portuguese project "Human Merchandise 4", the winner of the 2023 European Crime Prevention Award (ECPA) providing insights into this phenomenon by increasing the knowledge to prevent repeated and secondary victimisation as well as alerting society to its individual and collective responsibility in combating human trafficking.
