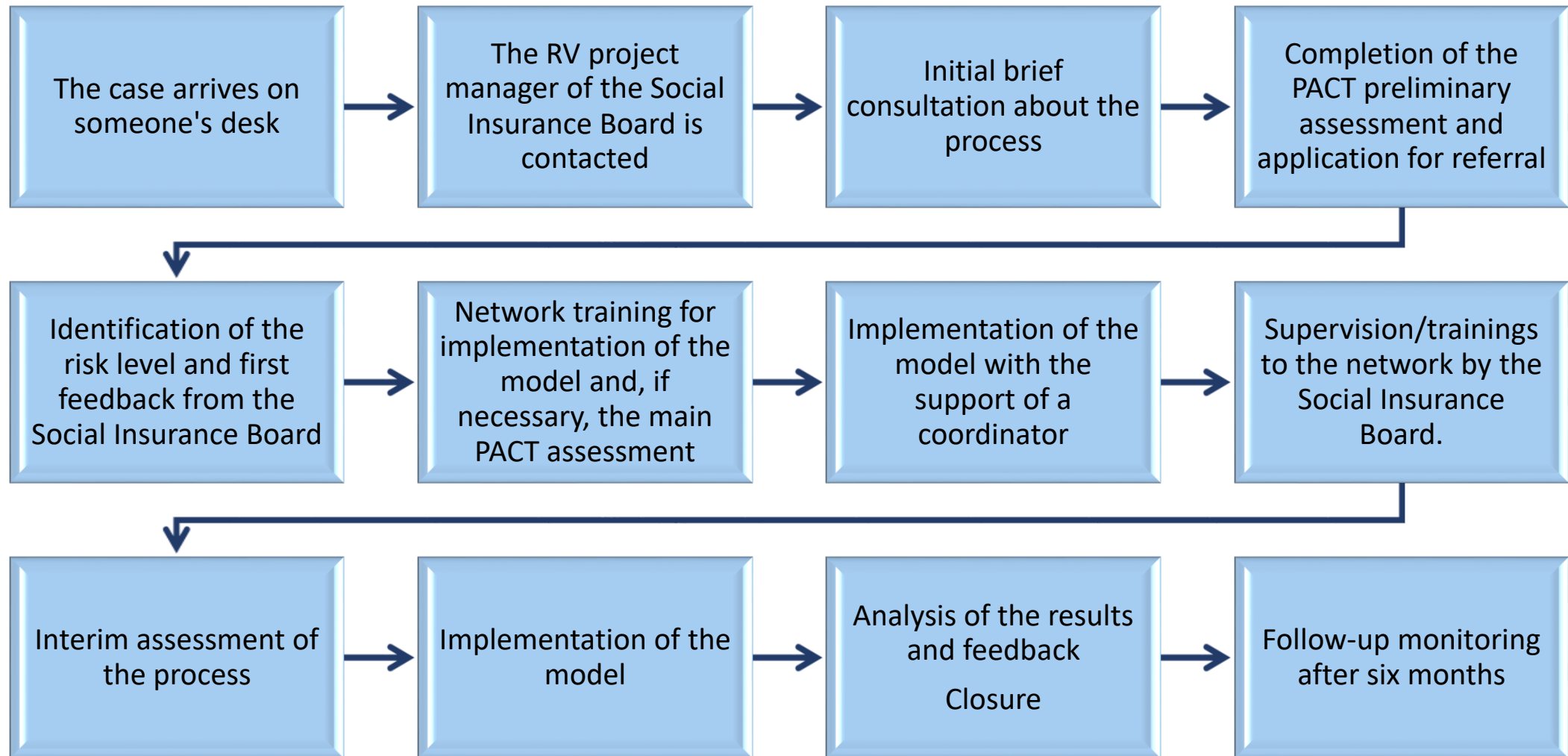
‘Ringist välja’ in short

‘Ringist välja’ (breaking out of the circle) is a model based on intensive networking in order to support a young person who exhibits medium or high level risk behaviour.

‘Ringist välja’ is used in complicated and multi-problem cases where everyday cooperation and information exchange are not enough.

‘Ringist välja’ is not a programme but a networking tool developed to create and maintain behaviour change in delinquent youth.

Current work process

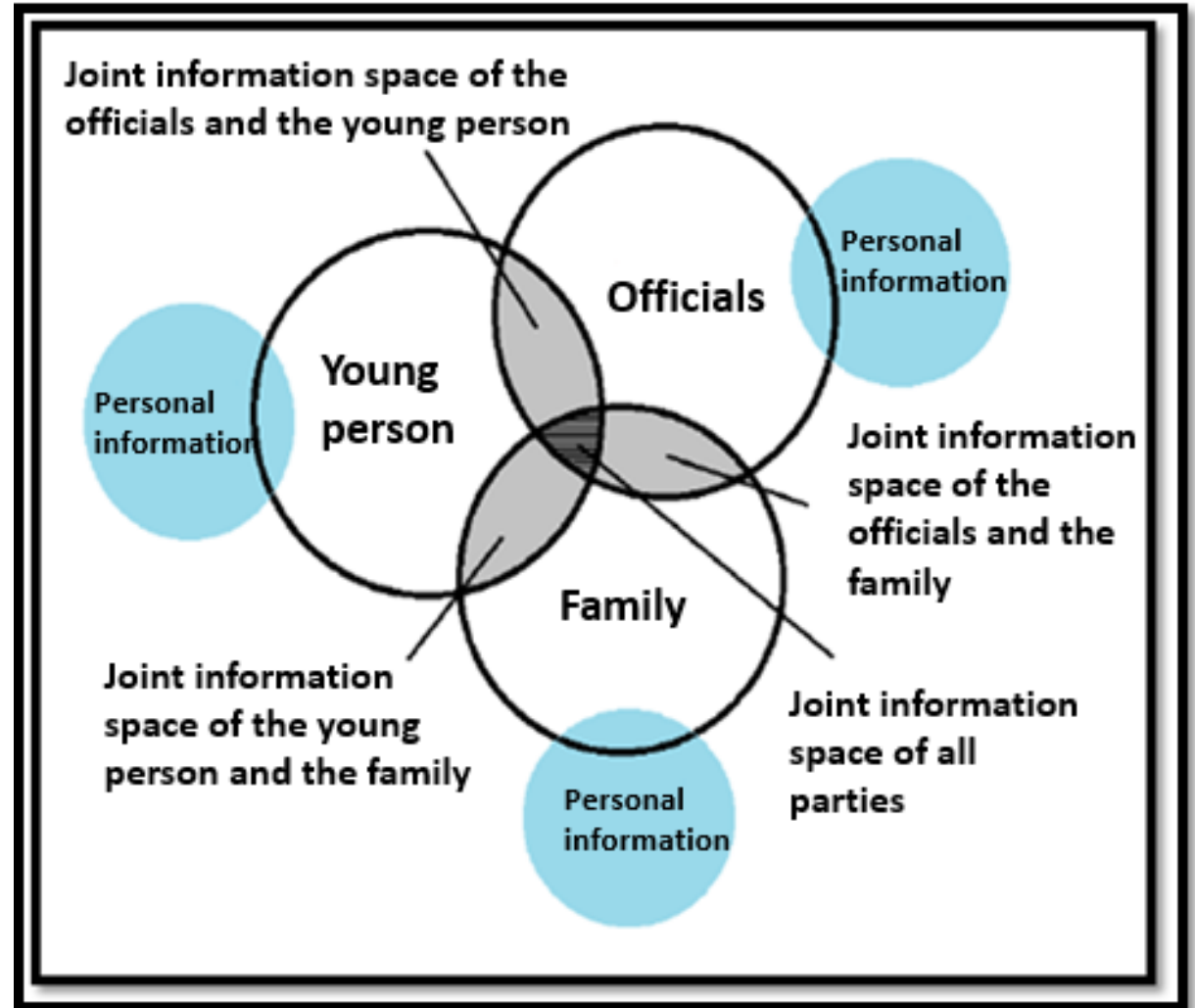

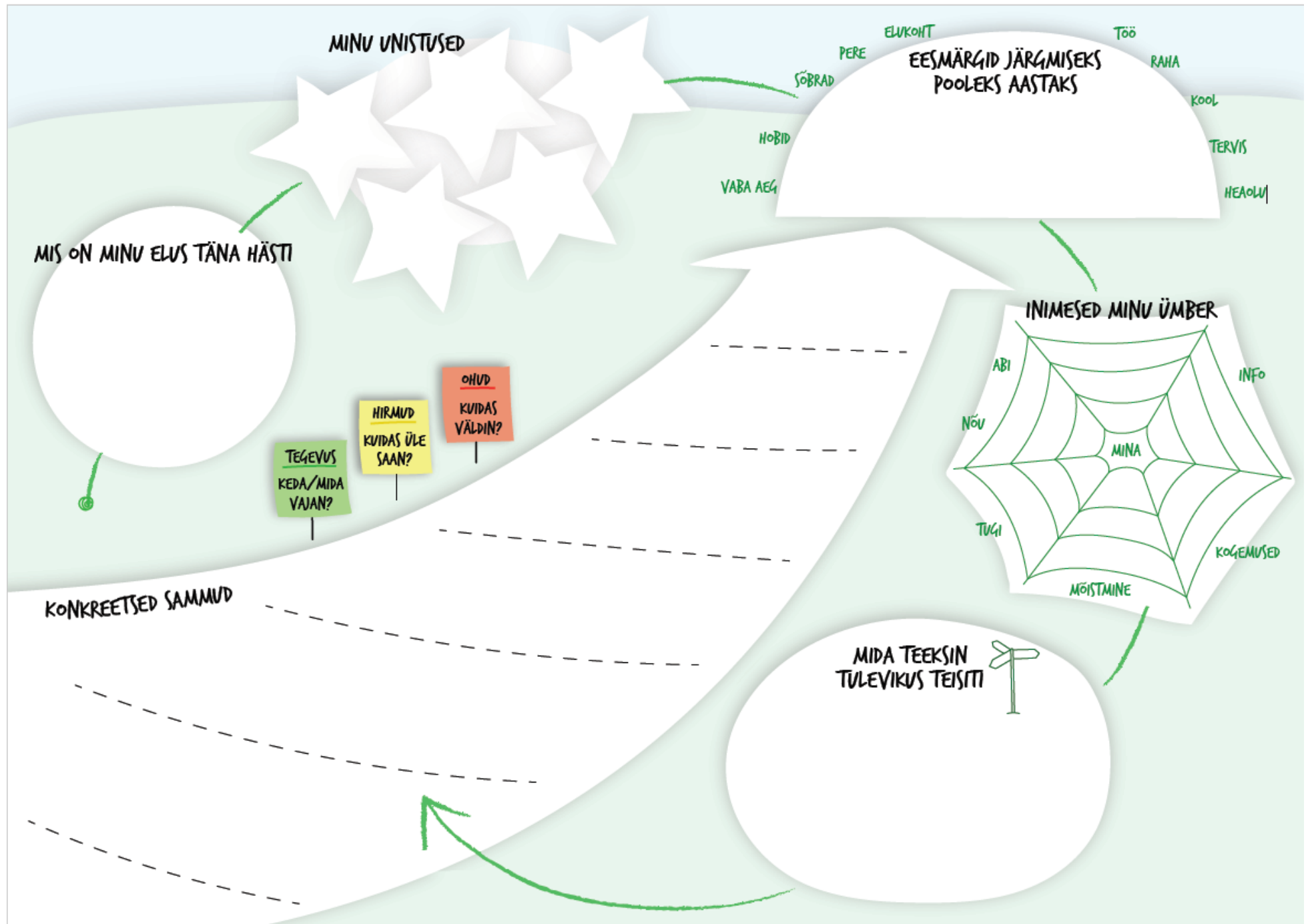

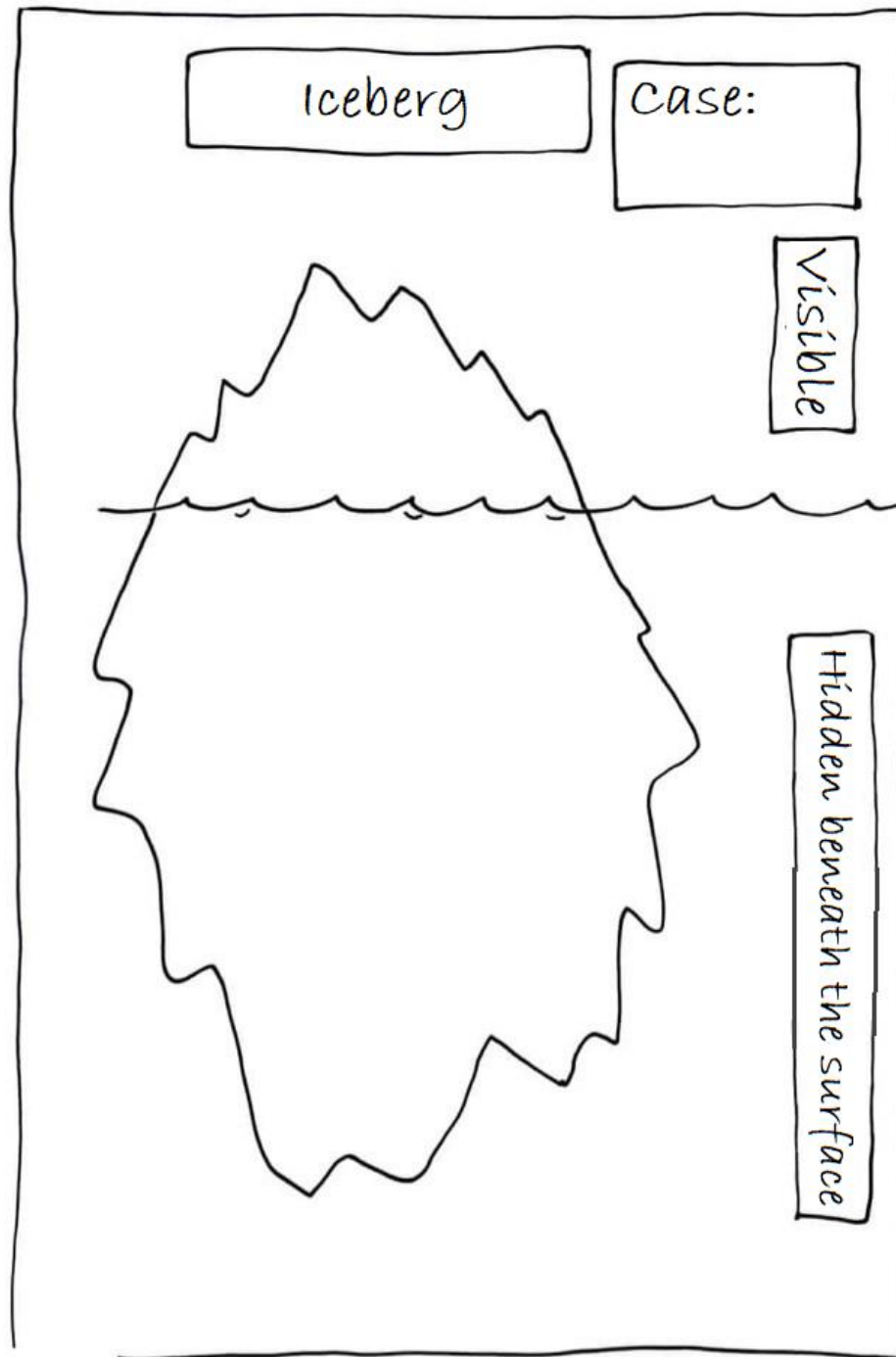

‘Ringist välja’ keywords

- The young person is in the centre of all plans and activities
- Focusing on the young person's strengths, not only weaknesses
- Sharing responsibilities
- A support person – trustee – chosen by the youngster
- Active family involvement in the ‘Ringist välja’ network
- Confidentiality
- Restorative justice
- Quick and systematic information exchange
- Intensive and well-structured
- In-depth assessment of risks and strengths (PACT model)

‘Ringist välja’ success factors

- Clear distribution of roles
- Having a process manager
- Early engagement of network members in developing the model
- Political support (national and local level)
- Constant learning, incl. freedom to make mistakes
- Common training and team-building – not only once!
- Creating and maintaining motivation and inspiration
- Fast, regular and efficient information exchange
- Having a trustee for the youngster – own choice!
- Strong and visible faith in the positive change of the youngster
- Sincerely caring about the youngster

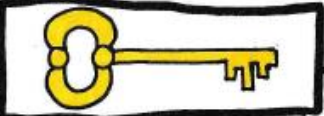
'Ringist välja' challenges

- How to achieve a common mindset with changing specialists?
- How to train new members and trustees on the go?
- Using volunteer trustees → compensating their time?
- Varying workloads of different parties
- Motivating the youngster and parents to really participate
- Turning 18 → automatic changes in services and case workers
- Changing place of residence → gap in services
- Can the network keep functioning on its own?
- The impact of COVID-19 → switching to online work

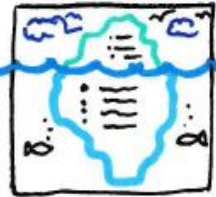

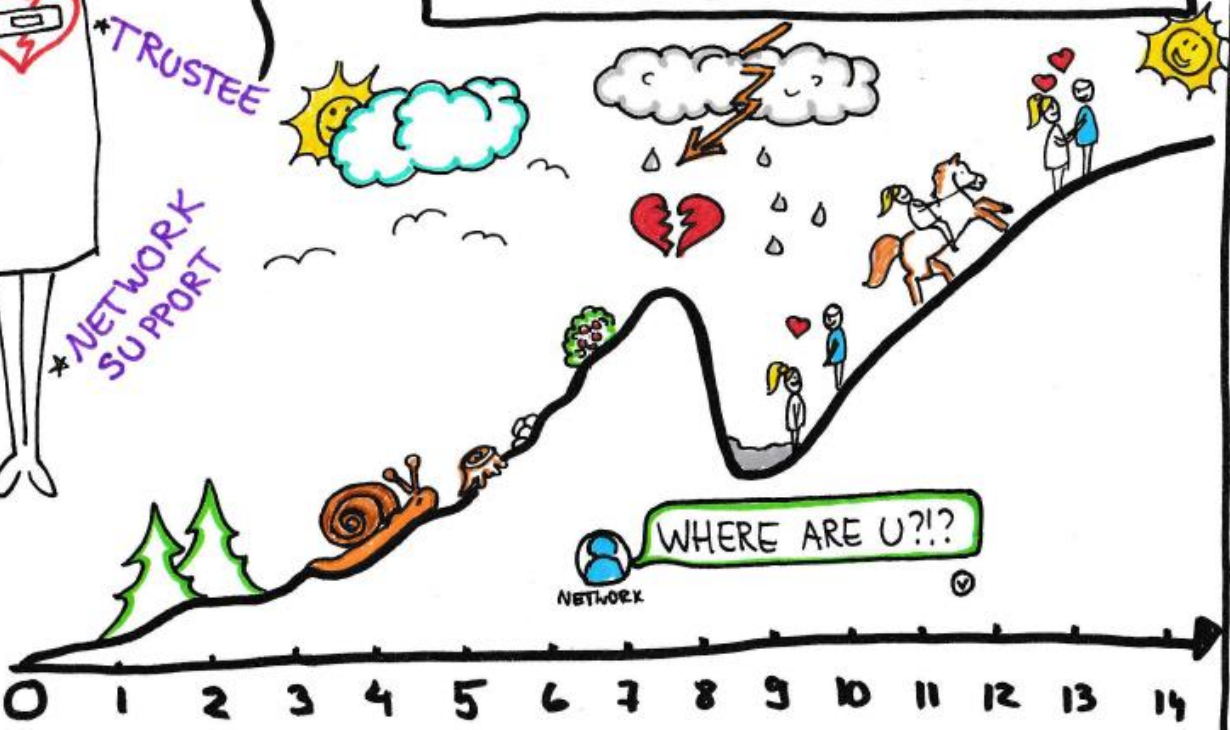
