ON 12 MARCH 2018, AN AGREEMENT WAS SIGNED BETWEEN THE GENERAL DIRECTORATE OF POLICE AND "DOWN ESPAÑA" ASSOCIATION, WITH THE AIM OF PROTECTING PEOPLE WITH DOWN SYNDROME AND PROMOTING THEIR INCLUSION IN SOCIETY.

IT INCLUDES THE IMPLEMENTATION OF DIFFERENT ACTIVITIES, AMONG WHICH THOSE, AIMED AT SAFETY TRAINING FOR PEOPLE WITH DOWN'S SYNDROME, PLAY AN IMPORTANT ROLE.

IN THIS CONTEXT AND IN ORDER TO MAINTAIN THE LEVEL OF COLLABORATION EXISTING TO DATE, IT HAS BEEN AGREED WITH "DOWN ESPAÑA" ASSOCIATION TO ESTABLISH A DECENTRALISED CYCLE OF TRAINING ACTIVITIES FOR PEOPLE, PARTICULARLY WOMEN ("WOMEN WITH COURAGE") ON THE PREVENTION OF GENDER-BASED VIOLENCE AND OTHER TYPES OF ABUSE (e.g. ICT RISKS)

EACH CITIZEN PARTICIPATION DELEGATE HAS REACHED OUT TO THE DOWN ASSOCIATION IN THEIR TERRITORY AND THE TYPE OF WORKSHOP REQUESTED - FACE-TO-FACE / ONLINE - HAS BEEN PLANNED.

THE CONTENT OF THE TRAINING TALK HAS BEEN PREPARED BY THE CENTRAL UNIT OF CITIZEN PARTICIPATION TO HOMOGENESE THE CONTENTS, WICH HAVE BEEN ADAPTED TO AN EASY-TO-READ FORMAT BY "DOWN ESPAÑA " ASSOCIATION, IN ORDER TO FACILITATE UNDERSTANDING BY PEOPLE WITH INTELLECTUAL DISABILITIES.
