1. Overview of the field

Definition of Illegal migrant smuggling

As it is describer under Article no. 353 of the Hungarian Penal Code:

- (1) Any person who provides aid to another person for crossing state borders in violation of the relevant statutory
- provisions is guilty of a felony punishable by imprisonment not exceeding three years.
- (2) The penalty shall be imprisonment between one to five years if illegal immigrant smuggling:
- a) is carried out for financial gain or advantage; or
- b) involves several persons for crossing state borders.
- (3) The penalty shall be imprisonment between two to eight years if illegal immigrant smuggling is carried out:
- a) by tormenting the smuggled person;
- b) by displaying a deadly weapon;
- c) by carrying a deadly weapon;
- d) on a commercial scale; or
- e) in criminal association with accomplices.
- (4) Any person who engages in preparations for illegal immigrant smuggling is guilty of misdemeanor punishable
- by imprisonment not exceeding two years.

Assessment of trends and developments

The modus operandi (concealments in lorries, minivans) is common both along the RS-HU border and the RO-HU border. The number of apprehensions significantly increasing once again, due to worse weather conditions.

Concealments in freight / cargo trains departing from RS via Kelebia BCP is still common, prevailing trend. Modus operandi: cutting hole into the wooden floor of containers than reattach the cut part in order to mislead border checks. Place of boarding: Serbia, most of the time at Subotica rail station.

Additional trends, elements:

- slightly decreasing nr. of detected AFG illegal migrants
- heavily increasing nr. of detected SYR illegal migrants TOP 1 nationality amongst detected migrants in November 2019.

Recent overview of statistics and research

- number of investigations initiated because of smuggling of people in 2019:
 214 cases
- number of persons charged with smuggling of people in 2019: 183 people



 TOP nationalities apprehended in 2019: Afghan, Syrian, Iraqi, Iranian, Pakistanian
