Trends:	<p>Master Plan for Coexistence and Improvement of the School Safety:</p> <p>The report done by the Coordination Cabinet of the Secretariat of State for Security in July 2008 for the whole Schools, shows as a consequence of the monitoring and control of the Plan application and its results, after the statistical treatment of the figures obtained and subsequent analysis, it can be said generally that:</p> <ol style="list-style-type: none"> 1. The security environment in the schools must be classified as

The data provided by the different Units of the Spanish National Police, allow concluding that there has been NO notable risk events for minors and youngsters on the various aspects of the plan. 3. It is also highlighted the majority percentage of known events done by students of Spanish nationality, 81.3%. About the Spanish nationality students who are victims, is 86.3%. 4. Over 50% of young perpetrators are between 12 and 15 years. 5. In general, as conclusion, it can be said that it has increased considerably the work developed by the Security Forces with the introduction of the Master Plan, both in specific activities and complementary, in the field of minors and youngsters in the school scope.
